- **1. Quorum Call**: <u>5:32 PM</u>, Board members present: Ward Wells-President, Howard Williams-Vice President, Bernie Bernard-Secretary, Kevin Griffin-Asst-Secretary, <del>Cecivon Garcia-Treasurer</del>. *Quorum was met*. Visitors: Hank McQuaid (HOA Manager), Paul Wolfe (ACC Chair).
- 2. Prior Board meeting minutes: meeting of 19 February 2019 minutes were approved unanimously.
- **3. HOA Mgmt report:** There is currently only 1 dues delinquency. Dues payments for 2019 are almost exactly on track thru Feb with those of 2018 and 2017.
- 4. HOA Committee reports (Board Liaison):
- a. <u>Maintenance & Landscaping (Kevin)</u>: Kevin and Bernie met with City (Billy Bonifazi) on-site to discuss repairing ruts made by vehicles on the shoulder of our main-entrance exit lane. City has now repaired them. <u>Hank</u> will have an obvious limb cut from a tree in that median that seems to be encouraging trucks to swerve onto the shoulder during their exit. Committee is starting to make small repairs/upgrades to selected items in the Commons, including the dam-frontage gate renovation (gate is in the shop right now). <u>Kevin</u> will draft an email that <u>Bernie</u> will send out to homeowners, soliciting additional participation for planning and managing this upgrade-initiative. <u>Kevin</u> will draft an email that <u>Bernie</u> will email to homeowners, suggesting that they mark any wildflowers on their property's edge that they want protected against accidental mowing of right-of-ways.
- b. <u>Architectural Control (Cecivon)</u>: Paul presented signatures to the Deed-Restrictions amendment for each Nantucket phase. All 13 phases are now ratified for the amendment. <u>Ward</u> and <u>Bernie</u> will sign as officers, will have notarized, and will give back to Paul submit to Cully Lipsey this week. <u>Bernie</u> will put on our web site the HOA form for submitting a rental agreement once he gets it from <u>Paul</u>. Homeowners would mail a completed form to the HOA Manager (BHH), and BHH would forward a scan to the Board.
- c. <u>Traffic (Ward)</u>: Ward reported his suspicion that the county's Arrington Road renovation project will be delayed. He also reported on Local/State/Federal plans for new high-capacity traffic corridors (loops) around BCS.
- d. <u>Lake & Park (Bernie)</u>: Bernie reported that some spillway rip-rap has been dislodged and needs to be returned to the rip-rap field. <u>Hank</u> will have this done.
- e. Financial (Cecivon): We have \$109,707 cash.
